CONDITIONS STORE LOCATOR EMERALD ETERNAL GREEN

We offer external (sales) partners the opportunity to sign up for our store locator, so they can be found better and faster by (potential) customers. By registering for the store locator, the (sales) partner declares to be familiar with and to comply with the (minimum) conditions for participation in the EEG store locator as stated in this document. The final assessment as to whether a (sales) partner sufficiently meets the conditions listed below will always remain at the sole discretion of EEG.

In order to participate as an external (sales) partner in our store locator, the following minimum conditions apply:

- The store locator is merely a tool made available on the EEG website. EEG offers no guarantees for, and accepts no liability in case of, not appearing in the store locator as a (sales) partner or the (temporary) unavailability of this store locator tool due to any technical malfunction, defects, delay or for any reason otherwise.
- No guarantee is given by EEG as to the correctness and reliability of any information contained in the tool.
- EEG may at any time decide to discontinue the use of the store locator without being held liable and without being obliged to pay any compensation or damages.
- EEG can at all times decide to refuse a (sales) partner, to remove them from the store locator and/or to change the name of a partner, without giving any reason. EEG does not accept any liability for this and is also not obliged to pay any (damage) compensation in that case.
- (Sales) partners are indicated in the store locator by means of a name to be provided by them. EEG obliges
 its (sales) partners to state their trade name as registered in the local Chamber of Commerce. Only under
 strict conditions and with the written approval of EEG, parties may deviate.
- There must be a representative, physical store. Participation in the store locator is excluded for (sales) partners with a store registered at a residential address or another address not accessible to public.
